Actual TSR performance translates into an award payment in January 1998 of 150% of Performance Shares Awarded.
- (02) Shares held in trust are held in the Rayonier Investment & Savings Plan for this person's account.
- (03) Shares held by Summer Reign, Inc., a corporation of which Mr. Nutter and his spouse are the sole stockholders.
- (04) Vests in one-third installments annually commencing January 2, 1999.
- (05) Performance Shares are paid in Rayonier Inc. Common Shares in an amount ranging from 0 to 150% of the Performance Shares awarded based upon Rayonier Inc.'s total shareholder return performance during the period from January 2, 1998 to December 31, 2000.
